This working paper is a bottom-up initiative of a group of stakeholders from the European repository community. Its purpose is to outline an aspirational vision of a European Network of FAIR-enabling Trustworthy Digital Repositories (TDRs). This initiative originates from the workshop entitled "Towards exploring the idea of establishing the Network". The paper was created in close connection with the wider community, as its core was built on community feedback and the first draft of the paper was shared for community-wide consultation. This paper will serve as input for the EOSC Task Force on Long Term Digital Preservation. One of the core activities mentioned in the charter of this Task Force is to produce recommendations on the creation of such a network.



Project goal



The FIDELIS project aims to further develop and implement the vision set by the community in this paper and establish, by the end of a three-year project,

a healthy, vibrant and self-sustaining network of TDRs that will foster a supportive open science environment and guarantee FAIR data sharing also in the future



Set up, develop, and operate a European network of trustworthy repositories that will support the development and growth of TDRs within the EOSC ecosystem Foster harmonisation and interoperability across repositories to enable an EOSC federation of TDRs Strengthen the upskilling of repositories and expansion of the Network through an active training and support programme

Serving the repository community



- The Network strengthens your message, position, expertise and collaboration options:
 - "Common voice": stakeholder advocacy and engagement
 - Networking and facilitation of knowledge exchange
 - Coordination and development of repositories



- You are invited to co-create the Network during the stage of *provisional* membership (i.e. until 2027):
 - The Network governance, including possibly different tiers of membership
 - A sustainable business model, looking at value-add and resourcing to sustain the Network after the project
 - Discuss how the Network aligns and collaborates with other organisations



- It is easy:
 - A modest shared foundation for *provisional* members.
 - FIDELIS will provide the secretariat.
 - Near the end of 2026 you have the option to evolve your membership.













FAIR data live in trustworthy repositories






To be transparent about specific repository services and data holdings that are verifiable by publicly accessible evidence.

To be responsible for ensuring the authenticity and integrity of data holdings and for the reliability and persistence of its service.

To ensure that the data management norms and expectations of target user communities are met.

To sustain services and preserve data holdings for the long-term.

To provide infrastructure and capabilities to support secure, persistent, and reliable services.



You have 4 months after registration as a member to arrange for the TRUST principles endorsement.





- The Network brings together views on what makes a repository trustworthy across disciplines like life sciences, environmental sciences, agrifood, social sciences, the humanities,...
- The project is developing the FIDELIS Transparent Trustworthy Repository Attributes Matrix (TTRAM)
 - Based on existing standards, criteria and frameworks
 - Uses 29 activities & functions that are relatively constant across all repositories
 - Identifies what information a repository should make transparent
 - Can be use to improve and align repository practices
- Trust is context dependent rather than binary and will take time to explore, including with future network members
- Common understanding of key concepts like trust, repository and preservation in the EOSC context
- Alignment and cooperation across EOSC (and beyond)

TRUST: User focus so that the data management norms and expectations of user community are served.

Repository training and support


- To promote mutual learning and peer-to-peer support
- Establish common programmes for training
- Improve trust in research by helping increase FAIRness and transparency



Data from the repository landscape survey indicates people value connection and support.

Q: The ability to connect with, learn from, and network with fellow participants, organisers, (guest) speakers, and other experts.

- Very important, 39%
- Slightly important, 44%





Repository Training and Support (Pillar 4)

Support routes:

- 1. **Cascading grants** Open calls for financial support and guidance to implement and adopt good practices, tools, and services for increasing trustworthiness
- 2. Training opportunities Continuous programme with two strands
 - 2.1. Technical topics for repository developers
 - 2.2 Topics related to repository governance and management
- 3. **Mentoring programme** Bridging gaps between more and less advanced repositories. Peer-to-peer hands-on support to help align with TTRAM standards and requirements
